an internal spiritual tension. When a person feels this and inclines to take a certain side or has taken that side from the very beginning, the best attitude is willing to learn from the other. Learning, however, is not for fusion, and certainly not for the lower level of recognition or tolerance, but for stimulating new interpretation of one's own classics due to the attraction of the other side. This is the best way in taking one's stand and learning from others. In saying that this learning is of a deep level is firstly because it requires a deep level of appreciation of the other in the way that the adherents would devote their life. Secondly, this learning will eventually require one to return to his own classics and rediscover its hidden treasures by reflecting on the spiritual resources he has learned from the other.

The deep understanding of the other side and the return to one's own classics in a deep and profound way defines the direction and meaning of this learning model,

i.e., through a new interpretation of one's classics the spirit of the other side is absorbed. Needless to say, the mutual learning at a deep level between Confucianism and Buddhism is a historical event and is the best precedent we can think of when considering the mutual learning between Confucianism and Christianity. We have seen the result that on one hand there was the sinicization of Buddhism, which gave rise to a new religion of great vitality and spreading to all parts of the world. On the other hand, we see the renewal of Confucianism having a broader and deeper scope through this mutual learning. We can therefore have similar expectation for the Confucian-Christian dialogue.

The Institute of Christian Culture at Tongji University joined the GNPT



In October 2016, Prof. XIE Zhibin, our Research Fellow in Mainland and Professor of Philosophy at Tongji University, attended the Global Network for Public Theology (GNPT) meeting on "Democracy & Social Justice in Global Contexts" at the University of Stellenbosch, South Africa and presented a paper on "The Plural Problem in Chinese Society: An Interpretation from Confucian and Christian Perspectives." In the event, Prof. Xie also introduced the academic programs, activities and publications related to public theology conducted by the Institute of Christian Culture at Tongji University (associated with ISCS' Tongji Center). The works of the Institute are recognized by the GNPT members and the Institute is accepted as a new member of the GNPT. Established in 2007, the GNPT is an academic research platform promoting theological contributions on public issues by engaging in dialogues with different academic disciplines. It includes more than twenty research centers, colleges and seminaries from all continents and publishes the International Journal of Public Theology. The Institute of Christian Culture at Tongji University is the first institute in Mainland China joining the GNPT.

Consultation of the Establishment of the *International Journal of Asian Christianity*



Between late October and early November 2016, our director Daniel Yeung was invited to attend the consultation of the establishment of the International Journal of Asian Christianity convened by the well-known Indian scholar Felix Wilfred. In the conference, Daniel shared the development of Logos & Pneuma: Chinese Journal of Theology and got acquainted with some Asian scholars. He also got the opportunity to have in-depth exchange on the theological development of the greater China with the theologian Prof. HUANG Pekho (黃伯和). Before the conference, Daniel visited the seven churches established by Apostle Thomas in Kerala. Introduced by his grace Mar Awa Royel, Bishop of the Diocese of California, Assyrian Church of the East, Daniel was welcomed warmly by Mar Awgin Kuriakose, Bishop of India, to stay in the Archbishop Palace with the Metropolitan Mar Aprem Mooken. In the meantime, Mar Awign brought him to visit many old Thomas churches and other Indian churches and seminaries. Daniel was glad to have the chance to talk with the two Bishops. Archbishop Aprem was a learned man, very familiar with the history of the Assyrian Church of the East in India. He had been the interim Catholicos-Patriarch during 2015-2016.

Exhibition and Seminar on the "Orthodox Church in China"



In the latter half of Nov 2016, Saint Apostles Peter & Paul Orthodox Church in Hong Kong hosted an exhibition and a seminar on the "Orthodox Church in China". ISCS has been promoting studies on the ecumenical tradition and keeping good relationship with different Christian traditions. Thus we coorganized this series of event. The exhibition of the "Orthodox Church in China: Past, Present, Future" was held at the Li Hall, St. John's Cathedral during 22-28 Nov 2017. It presented many valuable photos and information of the history of the Orthodox Church (Moscow Patriarchate) in China, in particular some were related to Hong Kong. In addition, there was an Orthodox choir singing session and a book fair in the opening ceremony. Prof. ZHANG Baichuen, ISCS visiting scholar and professor of philosophy at Beijing Normal University was invited to give a speech. The audience was deeply attracted by the history of culture of the Orthodox church in China.

On 25 Nov ISCS organized a seminar on "Sino-Orthodox Studies: Translation and Interpretation" with the City University of Hong Kong. The event was chaired by our academic officer Prof. Jason Lam, and Prof. Zhang also participated in the event and made responses to the papers. 
Visit of Prof. Hans-Martin Barth
