The Changing Scenario of Sino-Christian Theology

In 2003 Philip Jenkins of Pennsylvania State University

pointed out in his new book *The Next Christendom* that religious change, especially the progression of Christianity in non-Western countries, is another big event in the 20th century apart from Fascism, communism, the feminist movement and ecological concerns. "God in the global south" means the centre of Christianity moves from the



developed capitalist western world to the poor third world. At the same time when Christianity is developing quickly in post-colonial Latin America and Africa, Islam and Hinduism also manifest a similar trend in Asia, a continent that includes two thirds of the world population and has a long history of civilization. Correspondingly, there is also a revival of traditional culture in China in recent years. As the economics of China and its integrative power are rising up, the issue of establishing a modern Chinese culture becomes a heated concern.

In this situation, traditional Chinese culture, once severely criticized by the dominating political ideology, has

been revived and is hotly studied. Some universities established schools or institutes of Chinese culture, and Confucian colleges are set up in overseas countries. Some very old traditions and new practices including Feng Shui and astrology are built up under the flag of Chinese culture. This highly complex "Guoxue (study of Chinese culture) heat" has very strong spiritual power. It on one hand reinforces the quickly developing economic power and the expectations of a super state. And on the other hand it exhibits similarities with the revival of Islam and Hinduism – a kind of cultural conservatism.

In the last few decades China has experienced periods dominated by political ideology (1949-1978) and economics. We may say that it is now turning to an age led by culture. In the first stage the communist ideology has ruined the development of Chinese and western cultures in China. Since the open and reform policy was implemented, the market and various secular trends have created the society with pluralistic values. As the economic life and social institutions of the west exhibit many advantages, western culture has become a model for Chinese to learn and follow. Christianity as a kind of western faith is also admired by some Chinese.

In the last 30 years, the number of Chinese Christians has risen dramatically. Translated works and studies on Christianity also flourish. If westernization can be regarded as one feature of the age led by economics, then in recent years when the tide is led by culture the special phenomenon belongs to the revival of traditional Chinese culture. Since the economic development is very fast and the integrative power of the state rises, the national spirit is heightened. Political ideology also promotes traditional culture (Confucianism, Taoism, Buddhism and popular religions) and Guoxue. It will become a new challenge to Christianity.

It is expected that the "Guoxue heat" will emphasize the existential dimension of Confucianism. In various areas like the discussion of sin and salvation it will come into conflict with Christianity and create a real challenge, especially when conservative spirit and popular religions are coming to high tide at the same time. In the 21st century, how Sino-Christian theology should respond to this challenge could become a big issue. If in the initial stage the major work of Sino-Christian theology is to introduce the fundamental ideas and history of Christianity and translate major classics for the academic world in responding to the westernization trend, then it has really made a great achievement. Nowadays when we are facing a new cultural scenario, Sino-Christian theology must reorient its direction of development and strategy. Buddhism also reached a similar stage of enculturation after several centuries of transmission since the Han Dynasty. Therefore the most urgent issue for Sino-Christian theology would be the possibility and actualization of a Christian religion with "Chinese features" in the rise of nationalism and Guoxue. In other words, before we may talk about the Christianization of China, one must first deal with the Sinification of Christianity.

Against this background, Sino-Christian theology may encounter two opposite attitudes: 1. Some people may insist on keeping a sense of the purity and superiority of Christian faith and would try to transform the Chinese culture; 2. Some others may think that Christianity must first be indigenized to adapt to the situation and then try to exert influences on the future society. These two directions are already shown by Nicholas Longobardi and Matteo Ricci when Catholicism first came to China. The phenomena manifested in the last few centuries also tell us which direction has found better result. Today, Sino-Christian theology must make a similar decision.

The theoretical construction of Sino-Christian theology is different from traditional evangelization of the church. It is mainly facing the academia and thus must respond to the "Guoxue heat" in the intellectual dimension. In this stage, Sino-Christian theology should have some positive attitude to Chinese culture instead of the conservative spirit mentioned in the beginning of this article. It must understand the uniqueness and present situation of China and adjust its academic direction and objectives accordingly. Secondly, Sino-Christian theology should articulate the similar features between Christianity and Chinese culture, and make it a basis for dialogue and enculturation. Thirdly it must get beyond the conservative spirit and establish a Christianity with "Chinese features". However, at the same time it must criticize Chinese culture from the experience of the modernization of Christianity, so as to help the transformation of Chinese culture.

Two thousand years ago when primitive Christianity moved from Jewish circles to the Greco-Roman realm, it also experienced enculturation to form its Catholicism and Orthodoxy. Afterwards when it moved to the Germanic areas it also experienced a long period of indigenization and formed Lutheran, Reformed and Anglican traditions. In recent times, when Christianity left Europe it created liberation theology in Latin America, Minjung theology in Korea, and so on. These various kinds of theology all exhibit local cultural features.

Although some of these new forms may have been criticized by conservative people as heretical, they are supported by the local masses and developed healthily and formed new traditions and make Christianity flourish. In light of this, when Christianity encounters China, this ancient country with long and rich cultural traditions, it is very probable that some kind of Sino-Christian theology with Chinese features will be created. As the flourishing encounter of Buddhism with Confucianism in the past has shown us, the encounter between Christianity and Confucianism and other local cultural resources will probably create a new form of Chinese culture.

Editing a Reader in Chinese Christian Theology: Processes and Practicalities

It was a delightful coincidence to discover, as I was beginning to formulate a research plan for a Reader in Chinese Theology, that Prof. He Guanghu and Daniel Yeung were just putting the finishing touches to their Chinese-language Reader in Chinese Theology (漢語神學讀本). Having spent many hours in the last two months skimreading texts, I can testify to how much work goes into the seemingly simple task of preparing a Reader. I am also more convinced than ever that there is a strong element of the subjective in any selection: that there is no definitive list of texts which "should" be included in Reader of Chinese Christianity, but many possible selections, all of which outline a slightly different version of that textual history,

and which finally come down to editorial choice. A prime aim is balance: if an article on 'Homeland theology' is taken from one writer, then one on "story-telling theology" might be included by another; an article on Sino-Christian theology by a contemporary Hong Kong writer might be balanced by an article from the mid-1990s on the effect of retrocession on Hong Kong theology. If the aim of the Reader is to present a narrative of Christianity in China through representative key texts, then the overall structure of individual pieces is all important.

Terminology and definitions have become central to the question of what Chinese Christian theology is in Chinese-language debates. What seems to be at the outset a simple problem in English – drawing together representative texts from different eras of the best, or most influential, theologians or schools of theology in China, turns into a search to analyse the self-understanding of proponents of different theologies of China, different viewpoints on what a Chinese theology should be. It is not possible to be neutral on this; a selector cannot sit on the fence to observe debates. The question of definition has recently become a theological quest in itself, drawing much research attention, particularly at the geographical and intellectual boundaries between China and Hong Kong, threatening to overshadow the development of other strands of theology in China. This has been heightened by the creation and gradual expansion since the mid-1990s of the field of 'Sino-Christian Studies.' Underlying some of the convoluted ongoing debate is the well-known fact that the term "Sino-Christian theology" is used to refer both to a brand of Christian studies, predominantly academic in nature, begun by Mainland scholars in the 1990s, and to all theology, or studies of Christianity, written in Chinese.

In English the term "Chinese" is happily ambiguous, obviating the need to decide whether the language, people or nation is being referred to: "Chinese" in the phrase "Chinese Christian theology" refers most obviously to the entity "China" in its broadest historical and geographical senses, with possible readings and secondary senses "of the Chinese people" or "in the Chinese language". There is rarely a need to specify further: the speaker's notion of "China" is held to coincide with the listener's, and this hazy notion of 'China' is fit for most purposes. For an English language reader, a starting question is whether to include only Chinese theological writings which have specifically focused on China and the relation between Chinese theology and Chinese thought or culture (that is, a "Reader in

Chinese Chinese theology"), or to allow more widely any theological thought, which is "Chinese" by definition of being in Chinese or for a Chinese audience, and implicitly at least in dialogue with Chinese thinking. The parallel question in Chinese has been framed by debates on Sino-Christian studies, and the nature of a Chinese theology. The main debates around the "narrow sense" definition of the recent movement have focused around works and writings of Liu Xiaofeng and He Guanghu, and their respective constructions of Sino-Christian theology. Both emphasize the need for Chinese theology to draw on, and shape, the rich cultural resources available in the Chinese language, with He stressing theology's relationship to contemporary society in his formulation of a "mother-tongue theology", and Liu its equivalence with other language theologies in its direct access to the Christ event.

My reading of the debates over "Hanyu" does not persuade me that language is the sine qua non for Chinese theology. If we are not persuaded by the language nexus that He Guanghu articulates for Sino-Christian theology, what unifying factor(s) might undergird a Reader? In my (western!) understanding, the cultural background that is greater China and its multiple forms of Chinese is a stronger contender for defining belonging. The lived experience of Chineseness is greater than the absolute linguistic insistence on that Chinese being Hanyu. A Chinese theology reader must include all other traditions within China whether the mother tongue is Hanyu or not, since in both English terminology and in western thinking these are "Chinese". Sino-Christian theology in its narrow sense is one form of Chinese theology, part of the history of expression of human ideas on God in Chinese going back to the Tang dynasty. An English-language Reader will need to give full coverage to this and to other strains of Chinese theology. A greater breadth of pre-twentieth century pieces will probably be needed in the English language Reader to reflect the different arguments and turns in Chinese theology in its formational period. The English Reader, taking its cue from He and Yeung, will be structured chronologically and thematically - by setting periods determined the texts themselves and their debates, then presenting these in chronological order. It is an immense privilege to be involved in such a task - and the real work of translating has only just begun. To have had access to the Chinese Reader at this early stage has made the mammoth task so much more manageable, and I am very grateful to the ISCS for its support for the English Reader project.

Political or Theological? Some Personal Observation After a Seminar on Political Theology

On 9-10 Jan 2010, Prof. Michael Welker, dogmatic theologian at the University of Heidelberg, invited 5 advocates, participants and researchers of political theology for a seminar on "Political Theology: from Rahner to Ratzinger". This seminar was only open to



a limited audience of those who had made an application beforehand.

During the seminar, six theologians gave speeches for about one hour. The door of the discussion was firstly opened to the six theologians, and then to the audience.

The first speaker was Johann Baptist Metz, Catholic theologian from the University of Münster. In his sonorous oration he recalled the rise and development of the so-called "New Political Theology". Metz was a student of Karl Rahner and started the movement of "New Political Theology" after the Second World War with Jürgen Moltmann, Dorothea Sölle and others. Based on the experience of the Nazis and World War II he criticized the so-called "Old Political Theology" of Carl Schmitt, in order to understand and to interpret political theology anew from the perspective of theology.

Sharing with his advocacy and pursuit of a new political theology, the speech of Jürgen Moltmann, reformed theologian from the Unitersity of Tübingen, focused on the ecumenical beginnings and development of political theology, e.g., liberation theology in Latin America and the Minjung theology in South Korea.

The attention of Francis Schüssler Fiorenza, a Harvard systematic theologian with Catholic background, was given to the renaissance of the political theology of Carl Schmitt and its challenge to the contemporary intellectual world in the United States.

Elisabeth Schüssler Fiorenza, a feminist theologian from Harvard, was the only female theologian among the six professors. She did not like any "Herrschaftssprache" in theology. Her speech called for a "radical democracy" and

a critical, feminist theology of liberation. According to her viewpoint political theology should be significantly different from the "new political theology" advocated by Metz and Moltmann, because they do not pay enough attention to the oppressed in history, e.g. the women.

The theme of speech of Michael Welker was mainly about the dialogue on the future of religion between Jürgen Habermas and Joseph Cardinal Ratzinger on 19 Jan 2004. According to Welker the viewpoints of Habermas and Ratzinger are unrealistic and are just their personal good wishes.

Klaus Tanner, theological ethicist from the University of Heidelberg, gave the last speech, which was on political theology after Benedict XVI.

This seminar helped me have further and deeper observation on the relationship between theology and politics, especially after I had visited another seminar on public theology and Christian humanism held by Max Stackhouse, William Schweiker and Michael Welker.

- 1. The concrete proposal of public theology or political theology is related to the denominational background of the proponent. In this seminar Moltmann mentioned significantly his denominational difference with Metz. The reason why Elisabeth Schüssler Fiorenza advocated a feminist theology as a critical theology of liberation could be partly traced back to her Catholic background.
- 2. The concrete proposal of public theology or political theology has also a close relationship with the proponent's understanding of the "Zeitgeist". The political theology of Metz and Moltmann is based on their reflection on the crisis and suffering aroused from the Nazis and World War II. But younger theologians paid more attention to the diverse post-modern situations of contemporary western society, although they still have memory of the sufferings in the past. The Christian theologian should not be limited under the influence of the "Zeitgeist" and the concrete political situation. He should try to go back to the theology itself, in order to follow the rhythm of it.

5. Abstracts of Awarded Essays and Comments:

Master Student Group

LIN Lianhua Lanzhou University

"Research on the Testimony of Female Christians with Disability"

Abstract: This essay made use of narrative method to analyze the dual features of the testimony of Female Christians with disability: 1. The structure of going toward the holy; 2. The dualistic structure before and after conversion. From this we may know the significance of testimony to Christianity, and the influence of the narration method of Christian faith to contemporary believers.

Comments:

This master's thesis is a good piece of empirical study. Although the sample base and research method are limited and the conclusion is not very strong, the choice of topic, explanation of methodology and use of data reflect that the author has a very good training in social sciences.

SUN Guoling Shaanxi Normal University "Hope in This World and in the Other"

Abstract: This essay focuses on the suicide of Wang Zheng for his country during late Ming to illustrate the difference on the concept of hope between Christianity and Confucianism.

Comments:

This is an essay with very deep thinking and can provide a reference for research on the topic of Chinese Christian identity in cross-cultural perspective. But it does not solve a central problem: why did this man choose suicide if he has hope of a world beyond this one?

"Re-interpretation of Augustine's Confessions in Postmodern Theology"

Abstract: Various western scholars have reinterpreted the *Confessions* of St. Augustine of Hippo in the contemporary situation. This essay focuses on this phenomenon and explores the relationship between the human and the absolute other in the postmodern situation through Heidegger's and Derrida's readings.

Comments:

The author has a thorough understanding of related materials in contemporary academia, which leads the readers to a new perspective. In the beginning she introduces the relationship between modernity and postmodernity while at the end the differences between Augustine and Heidegger and Derrida – the latter two thinkers modern/postmodern – delayed the elements of faith in their writings. This point can be given more emphasis.

LI Shuqin Tsinghua University

"Reason and Belief"

Abstract: Q. S. F. Tertullianus is often rendered as a representative of fideism. This essay reviews his standpoint through psychological, philosophical and theological analyses to articulate some important elements for the relationship between faith and reason.

Comments:

The basic understanding of this essay is correct; the perspective is wide; and the arguments to the point. If it can integrated with more contemporary discussions, then a better result can be obtained.

Program of Mainland China Scholars Visiting University of Toronto

The conference was hosted by the Center of Christian Studies, China Academy of Social Sciences, and ISCS was one of the five cooperating partners. The topic of this year is on "Christianity and Economic Development". The number of participants was over 100. Dr. Lam and Dr. Huang presented papers on "The Religious Dimension of Modern Economics and a Reflection" and "The Influence of Christianity to the Great Guoxue as Chinese Image in the Context of Economic Crisis" respectively.
